1. CALL TO ORDER

Mayor Muecke called the meeting to order at 6:33 p.m.

4. REPORTS

A. Financial Report – June 2017 – Kelly Johnson, City Administrator/City Secretary-Treasurer

Kelly Johnson discussed the financial report:

- As of June 30, 2017, revenues were at 64% of budget.
- As of June 30, 2017, expenses were at 45% of budget.
- Total cash balance for the city is \$2.3 million.

B. Police Report – June 2017 Crime Report & Statistics – Police Chief Gott

Chief Gott discussed the police report:

- Chief Gott gave an overview of the June statistics.
- Chief Gott commended the police department staff in relation to the investigation of the murder that occurred in the city.
- Mayor Muecke commented on the murder of Janeil Bernard

C. Fire Department – Meeting – Fire Commissioner Bill Johnson

Fire Commissioner Bill Johnson was absent:

• No report

D. Drainage Committee – Update – Mayor Muecke

Mayor Muecke discussed the following:

- The Drainage Committee held a meeting on July 11th at the offices of LJA, Inc. The meeting lasted approximately two and a half hours.
- Three scenarios were discussed:
 - 1. A project along Magdalene with a new street and drainage. LJA, Inc. is working on elevation and pipe size.
 - 2. Street work only.
 - 3. Pipe running south directly to Buffalo Bayou.
- During a 100 year rain event, the city receives approximately 340 CFS of water from north of Barryknoll on Bunker Hill.
- There is no water coming into the city from north of I-10 rather it is encroaching on the feeder road from the west.

E. Planning & Zoning Commission – Meeting Update – Councilmember Shirley Rouse

Councilmember Rouse discussed the following:

- P&Z held a meeting on June 27th and the commission approved the recommendation to Council to reduce the number of members on the commission from nine to seven.
- P&Z discussed parking ratios for Phase II, which covers shopping centers and schools.

F. Mayor - Mayor's Monthly Report - Brian Muecke

Mayor Muecke discussed the following:

• The city has received the final draft of the panels for the trail markers as part of the Memorial Village Heritage Trail. Mayor Muecke will suggest several corrections. The installation is scheduled for some time in October.

G. Building Official - Monthly Report, Update on Noise Abatement - Lane Standley

Lane Standley discussed the following:

- Noise Abatement TxDOT is still estimating the completion of the I-10 Noise Abatement Project to be in August 2017.
- Permits for June are up from the previous month.

H. City Administrator -Village Independence Festival (VIF), 2018 Budget - Kelly Johnson

Kelly Johnson reported on the following:

- Village Independence Festival (VIF) City of Bunker Hill Village won first place for their float in the parade. Melissa Richardson, her family, and Terry Vick's crew worked very hard on the city's float. Councilmembers commented on how well the float looked.
- The first budget workshop is scheduled for August 10th at 8:00 a.m.
- **5. CONSIDERATION OF ORDINANCES** / **RESOLUTIONS** The City Council will discuss and consider possible action of the following:

An Ordinance of the City Council of the City of Hedwig Village, Texas amending Article II, Definitions and Interpretation, Section 202, Definitions, and Article V, Zoning Regulations, Section 506, Business District B, Subsection D, Parking of the Hedwig Village Planning and Zoning Code relating to the regulation of parking requirements for restaurants within the city.

Councilmember Barry Putterman requested the addition of language to Appendix A, an attachment to the Ordinance.

Councilmember Putterman moved, Councilmember Rouse seconded, to adopt Ordinance 701 as presented in the Council packet with the following changes to Appendix A:

Coffee, Bakery, and Dessert Shop – add the phrase "to the public" to line three after the word "cookies"

Fast Food Restaurant – add the phrase "to the public" to line three after the word "service"

Restaurant – add the phrase "to the public" to line two after the word "service" Restaurant Serving Alcohol – add the phrase "to the public" to line three after fl

Restaurant Serving Alcohol - add the phrase "to the public" to line three after the word "service"

Take-out Restaurant – add the phrase "to the public" to line two after the word "beverages"

Councilmembers Putterman, Rouse, Wiener, and Woodruff voted "Aye", "Noes" none.

An Ordinance calling a Joint Public Hearing to be held before the City Council and the Planning and Zoning Commission of the City of Hedwig Village, Texas, for the purpose of considering an amendment to Article V, Zoning Regulations, Section 506, Business District B, Subsection B, Height of Improvements to Property, of the Hedwig Village Planning and Zoning Code relating to the Regulation of Building Height within the Business District B.

The Joint Public Hearing will be held on August 10th at 9:00 a.m.

Councilmember Woodruff moved, Councilmember Putterman seconded, to adopt Ordinance 700 as presented in the Council packet.

Councilmembers Putterman, Rouse, Wiener, and Woodruff voted "Aye", "Noes" none.

Councilmembers Putterman, Rouse, Wiener, and Woodruff voted "Aye", "Noes" none.
