MINUTES

1. CALL TO ORDER

Mayor Muecke called the meeting to order at 8:02 a.m.

2. DISCUSSION OF THE 2018 PROPOSED BUDGET

Kelly Johnson attempted to call Councilmember McGinnis on the phone but was unable to reach him.

Kelly Johnson stated the 2018 Proposed Budget has increases in expenditures in several line items. The increases were:

- 1. Police Department proposed one new officer
- 2. Court proposed hiring one part-time employee
- 3. Pay increase of 3.5% for city hall personnel and 3% for police department personnel
- 4. Four new vehicles for the police department
- 5. One new vehicle for the building official
- 6. One maintenance truck
- 7. Replace current security cameras and add additional security cameras at city hall
- 8. Replace signal control and cabinet, to be paid for out of Child Safety Fund.

Kelly Johnson stated there were three possible tax rates:

- 1. The Preliminary Effective Tax Rate \$0.221256
- 2. The Preliminary Rollback Tax Rate \$0.235497
- 3. The Preliminary Drainage Improvement Tax Rate \$0.280000

Kelly Johnson discussed the benefits to the city of planning ahead for major expenditures. Large purchases or projects would be easier to fund in the future if the city had and followed a long-term reserve schedule. Councilmember Woodruff was in agreement.

Kelly Johnson and Lane Standley discussed the roadways in Hedwig Village, the age of the streets, and the maintenance needed to maintain them. Maintenance includes crack sealant for asphalt streets and sealant for concrete streets. Maintaining the streets would ensure the longevity of the concrete streets for 50 years and 25 years for asphalt streets.

Kelly Johnson stated the 2012 Debt Issuance will be paid off in 2022 and the 2014 Debt Issuance will be paid off in 2034.
